REQUEST FOR INFORMATION FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

Thank you for your request for the provision of the following information.

I would like to submit a Freedom of Information request for information pertaining to the following questions:

1. Since the legislation was legally commenced on 1 October 2023, how has NHS Ayrshire and Arran paid due regard to community benefit in non-emergency patient contracts, and the extent to which such contracts will improve economic, social or environmental wellbeing, to comply with its duty under Part 10, Section 120 of the Transport (Scotland) Act 2019?

The Procurement Reform (Scotland) Act 2014 requires the Board, as a minimum, to consider including community benefit requirements when tendering a contract with a value equal to or greater than £4,000,000 and if it decides not to it must include a statement of its reasons. At its meeting of 23 August 2022, the NHS Ayrshire & Arran Community Wealth Building Programme Board approved the mandatory inclusion of Community Benefits in contracts over £50,000 for goods and services and £1,000,000 for work contracts.

We are currently engaging with community transport services to explore how they can support us with a non-emergency patient transport service.

2. Since the legislation was legally commenced on 1 October 2023, how has NHS Ayrshire and Arran worked with bodies which provide community transport services in its area in providing non-emergency patient transport services to comply with its duty under Part 10, Section 121, Subsection 1 of the Transport (Scotland) Act 2019?
